**Contest Rules**

1. There will be no pre-registration and there will be no prize money. Ribbons will be awarded to 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place winners. Ribbons may be picked up at the tent following judging on Tuesday, August 20<sup>th</sup> until 5:00 p.m. on Sunday, August 25<sup>th</sup> when the Fair closes.
2. All entries are to be registered and received at the Agricultural Tent on Tuesday, August 20<sup>th</sup> (the day before the fair starts) from 9:00 a.m. to 2:30 p.m. Exhibitor’s name may not appear on the entry, only on the exhibitor card. Judging will begin at 3:00 p.m.
3. Exhibits must be called for by the exhibitor Sunday, August 25<sup>th</sup> at 5:00 p.m. Those exhibit’s still present after 5:30 p.m. will be forfeited by the owner and disposed of.
4. All articles must be raised and owned by the exhibitor. All entries must have variety name on tags. All articles must have been produced in New Jersey. Any item incorrectly entered will be disqualified at the judge’s discretion.
5. Any entries unfit to show will be disqualified.
6. After the exhibits are arranged, they will be under exclusive charge of the fair committee and not even the owner shall have the right to remove them until the exhibit is closed. The management may at any time remove an exhibit which is in bad condition.
7. A card containing the name and address of the exhibitor may be attached to the exhibit after it has been judged. No printed or written material advertising spray mixtures or implements of any kind will be allowed.
8. All classes are open to all exhibitors, but subject to above rules and regulations.

**CLASSES**

For best results; cut flowers early in the morning or evening, put in water, and place in a cool dry place the day before entries are due. Entries must be displayed in glass jars.

Classes:

- 901 Ageratum, 3 stems with blooms
- 902 Asters, annual 3 blooms or 1 stem
- 903 Chrysanthemum, daisy, 3 blooms
- 904 Chrysanthemum, pompom, 3 blooms
- 905 Chrysanthemum, any other, 3 blooms
- 906 Cleome, spider flower
- 907 Coleus, not in bloom
- 908 Cosmos, 3 blooms
- 909 Coxcomb, crested Celosia

- 910 Coxcomb, plumed, 3 spikes
- 911 Dahlia, large 1 bloom over 6"
- 912 Dahlia, small, 1 bloom, seedling or pomp om not over 6"
- 913 Gaillardia, annual, 3 blooms
- 914 Gladiolus, 1 spike
- 915 Gladiolus, 3 different colored spikes
- 916 Hostas, 3 leaves, exact size same type, labeled
- 917 Impatiens, 3 stems with blooms
- 918 Marigolds, large flowered, 3 blooms
- 919 Marigolds, small flowered, 5 blooms
- 920 Nasturtium, 3 blooms
- 921 Pansy, 3 blooms
- 922 Perennial – Grass – Named
- 923 Petunia, 3 stems with bloom
- 924 Phlox, annual, 3 stems with bloom
- 925 Roses (any type) 1 bloom or spray
- 926 Salvia, 3 blooms
- 927 Scabiosa, 3 blooms
- 928 Snapdragon, 3 spikes
- 929 Sunflower, 1 bloom
- 930 Sunflower, 1 specimen ready for harvesting
- 931 Zinnias, Large Flowered, 3 blooms
- 932 Zinnias, small flowered, 3 blooms
- 933 Any other flowering annual, 3 blooms or spikes of bloom
- 934 Any flowering shrub in bloom and properly identified
- 935 Collection of wild flowers (5 different species) properly identified on card
- 936 Collection of garden flowers (5 different species) properly identified on card
