Contest Rules

1. There will be no pre-registration and there will be no prize money. Ribbons will be awarded to 1st, 2nd and 3rd place winners. Ribbons may be picked up at the tent following judging on Tuesday, August 22nd until 5:00 p.m. on Sunday, August 25th when the Fair closes.
2. All entries are to be registered and received at the Agricultural Tent on Tuesday, August 21st (the day before the fair starts) from 9:00 a.m. to 2:30 p.m. Exhibitor's name may not appear on the entry, only on the exhibitor card. Judging will begin at 3:00 p.m.
3. Exhibits must be called for by the exhibitor on Sunday, August 25th at 5:00 p.m. Those exhibits still present after 5:30 p.m. will be forfeited by the owner and disposed of.
4. All varieties must have a variety name on tags. Any item incorrectly entered will be disqualified at the judge's discretion. Any entries unfit to show will be disqualified.
5. Management may at any time remove an exhibit which is in bad condition.
6. After the exhibits are arranged, they will be under exclusive charge of the fair committee and not even the owner shall have the right to remove them until the exhibit is closed. The management may at any time remove an exhibit which is in bad condition.
7. A card containing the name and address of the exhibitor may be attached to the exhibit after it has been judged.
8. All classes are open to all exhibitors, but subject to the above rules and regulations.

Classes

The container will be furnished for 1 quart exhibit of loose grain.

100. Winter Barley, 1 quart
101. Winter Oats, 1 quart
102. Spring Oats, 1 quart
103. Rye, 1 quart
104. Wheat, red, 1 quart
105. Soybeans, yellow, 1 quart
106. Soybeans, black, 1 quart
107. Shelled corn, 1 quart
108. Best single ear of corn, any variety
109. 10 ears of corn, any variety

HAY– 5-pound slice of bale Slices of hay must have come from a bale and must be securely tied or will not be accepted.

ALFALFA AND ALFALFA-GRASS MIXED HAY

- 110. Alfalfa (Field Cured) first cutting, not over 10 percent grass
- 111. Alfalfa (Field Cured) subsequent cuttings, not over 10 percent
- 112. Alfalfa grass mixture (Field Cured) first cutting, a mixture containing more than 10 percent, but not over 50 percent grass
- 113. Alfalfa grass mixture (Field Cured) subsequent cuttings, a mixture containing more than 20 percent, but none over 50 percent grass.

RED CLOVER AND CLOVER-GRASS MIXED HAY

- 114. Red Clover (Field Cured), but not over 20 percent grass
- 115. Ladino and grass mix
- 116. Red clover-grass mixture (Field Cured), a mixture containing more than 20 percent, but not over 50 percent grass
- 117. Red clover, subsequent cutting

GRASS HAY AND OTHER ANNUAL AND MISCELLANEOUS HAY

- 118. Grass, not more than 10 percent legumes. Brome, orchard grass (Field Cured) one entry.
- 119. Timothy (Field Cured), one entry only. No more than 10 percent legumes.
- 120. Annual hays- Soybeans, Sudan grass or Oats (Field Cured), one entry only.
- 121. Annual hays, subsequent cuttings
- 122. Wheat straw
- 123. Oat Straw
- 124. Rye Straw
- 125. Barley

BIGGEST AND LONGEST

- 126. Four tallest stalks of Hybrid Field Corn with a clump of roots, average length
- 127. Four tallest stalks of Hybrid Field Corn, open pollinated, must give company and number
- 128. Longest 6 sheaves of soybeans
- 129. Longest ear of Field Corn, last year's crop
- 130. Tallest Sunflower with clump of roots
- 131. Tallest Broom Corn-4 stalks with clump of roots, average length
- 132. Tallest single stalk of field corn
- 133. Tallest amaranth
- 134. Corn silage
- 135. Popcorn
- 136. Grass Hay subsequent cutting
- 137. Timothy subsequent cutting
- 138. Orchard grass 1st cutting

140. Tallest sorghum
